Speaker: Ed Fong – (retired SSD) is now a lawyer specializing in Estate Planning, Trust Administration and Probate. He served as an intern at the Sacramento Superior Court for 15 months and learned “behind the curtain” court operations and how to draft bench memos for the court. He also worked for a veteran probate attorney before opening his own office.

Estate Planning can cover from your parents to you, you planning to keep your parents going and you keeping your assets and passing on to your choice. Assets would include, county retirement benefits, whole life insurance policies, military retirement, 457 plan and the Homestead Exemption.

A Revocable Living Trust determines what happens when you are alive, incapacitated and after your death. Upon having a living trust prepared it is important to transfer/fund your trust. The trust also includes a Pour Over will in case you forget something, Power of Attorney for Financial and Medical and your Final Disposition plans.
